Abstract:	The Rhode Island Constitutional Convention of 1986 was convened to revise the State's Constitution. The collection is primarily composed of background and historical texts, committee proceedings, delegate correspondence, hearing transcripts, and files related to the ratification drive. The collection also includes broadcast video film of many of the sessions.

Historical Information

On November 4, 1986, the people of Rhode Island altered their most important State document, the written compact with each other and with their government, the State Constitution. This basic contract was the product of one year's work by one hundred elected delegates from a cross-section of the population, most with relatively little previous political involvement. This "people's convention," through a statewide series of lively public hearings, encouraged the interest of and commentary and participation by the general citizenry.

The 1986 Constitutional Convention was an unlimited Convention that began in January, 1986. The Convention met at the State House and at the Garrahy Judicial Complex in Providence. Kevin A. McKenna was President of the Convention, Albert Rainville, Vice-President, and James R. Langevin was Secretary. One hundred delegates, representing each R.I. district, took part. Governor Bruce Sundlun (1991-present) caused a controversy when he announced his bid to run for the 1986 race against incumbent Edward DiPrite. After some debating, he was eventually allowed to remain as a delegate.

Of the three hundred and twenty-two resolutions considered by the delegates, twenty-four, condensed into fourteen ballot questions, were put before the voters. The records documenting the evolution of the Constitution reflect the public will on the eight successful questions and the six failed. In addition, the collection has allowed scholars to analyze the legal and social interpretations of the convention as well as observe the inner workings of this law-making body and the process as a reflection of its time.

Scope and Content Note

The Papers were divided into twenty record groups in a rough chronological order, beginning with background information through General Laws publication of the new Constitution approved by the voters. Background information, such as the Constitution as it read prior to the Convention, a Preparatory Commission Report and General Assembly enabling legislation, set the stage. Plenary Sessions Journals contain the official digest of the fourteen meetings of the entire assembly.

Because, as in most legislative bodies, the members assigned proposals to committees for in-depth discussion, the resolutions are arranged by committee in numerical order. The committee files also include meeting and public hearing records, research staff reports and information responses, legal staff opinions, committee reports and correspondence.

Through twelve public hearings, delegates invited comment from individuals and groups on virtually all subjects before the Convention. In turn, a Public Information Office kept both the delegates and the general population abreast of upcoming events and the status of individual proposals. Internal workings of the Convention are reflected in the general delegate correspondence, individual delegate requests, personnel files and budget records.

The ratification drive record group includes the product of the Convention's deliberations, from drafts of the proposed new Constitution to the ballot put before the voters. The public relations efforts, including edited video tapes of plenary sessions, undertaken to explain to, and recommend passage by, the citizens of the State are also included. The last section contains the voting results and published versions of the Rhode Island Constitution of 1986.
